Re: July 2013 Strategic Plan Update

This month's *Strategic Plan Update* shows that the academic excellence, educational opportunity, and social responsibility of Western Illinois University continue to receive state and national recognitions.

- The Higher Learning Commission-North Central Association of Colleges and Schools previously approved WIU's participation in the off-campus notification program. This is an honor reserved for the top one percent of institutions in the 19-state association. It allows the University after receiving institutional and state approvals to notify—rather than apply—to the Commission for new Illinois off-campus locations. WIU's notification portfolio has been expanded to include all 50 United States. This is the highest honor for institutions with off-campus programs in the U.S. Other classifications are prior commission approval required and notification only within the 19-state Commission region.
- WIU's Peace Corps Fellows Program in Community Development administered by the Illinois Institute for Rural Affairs received a \$130,000 grant from the Corporation for National and Community Service. Peace Corps graduate students complete their studies and an 11-month internship in an underserved rural Illinois community. More than WIU 100 students and have participated in this program since 1994.
