## Martinelli-Fernandez named CAS dean

**Susan Martinelli-Fernandez**, College of Arts and Sciences interim dean, has been named the college's dean following a national search, effective July 1, according to Provost and Academic Vice President **Jack Thomas**.

Martinelli-Fernandez has served as interim CAS dean since July 2009. She is also serving concurrently as associate dean, a position she has held since 2005. She is also a professor of philosophy, and has served as a faculty member in the philosophy and religious studies department since 1993.

Martinelli-Fernandez served as the interim associate director of Western's Centennial Honors College (2004-2005). Prior to joining Western's faculty, she was an adjunct faculty member at the College of St. Francis (now University of St. Francis) (1988-1989) and at Mundelein College (now Loyola University) (1988). She earned her doctorate and master's degrees from the University of Chicago and her bachelor's degree from Mundelein College.

## FY'11 budget update

Dear Campus Community:

As you may be aware, Western Illinois University's University Professionals of Illinois (UPI) WIU Chapter Executive Committee has reached a tentative agreement with the University. The contract is now being reviewed by UPI membership for a vote later this month. As part of the tentative contract, UPI has agreed to forgo a 3.5 percent pay raise for FY'11 due to the difficult budget situation forecast for the next fiscal year.

I greatly appreciate the UPI leadership's commitment to working through a new five-year contract and for recognizing the dire budget situation. Following a ratification vote, the contract will be forwarded to the WIU Board of Trustees for consideration at the June 4 meeting.

At the same time, I regret that the current economic situation and the budget situation necessitates that I inform the rest of the campus community that we will be unable to provide across-the-board pay increases in FY'11. While it is unfortunate we cannot provide an increase, this measure is a far more preferable option than furloughs or layoffs. The savings to the University total approximately \$2.8 million. Please know that in the past years, all of our University employees have been fortunate to receive pay increases and that

my hope is that the economy will turn around as soon as possible so that we can implement pay increases once again.

However, to limit the effect on those employees who are retiring in FY'11, the University will provide a 3.5 percent salary increase to those non-negotiated individuals who sign an irrevocable retirement agreement. While SURS will not include such an increase for non-negotiated employees when computing their final rate of earnings (FRE) prior to retirement, such funds could help employees either add funds to self-funded retirement accounts or be used to purchase previous years' credits. Employees in positions covered by collective bargaining agreements shall follow the specific terms of their respective contracts.

I appreciate your cooperation and understanding during these incredibly challenging economic times, and I am thankful for your commitment to Western Illinois University.

## IBHE approves University Union upgrades

The Illinois Board of Higher Education (IBHE) on April 6 approved Western Illinois University's capital project request to renovate the University Union entryway and to install an elevator for public access to the Union Heritage Room.

Western's Board of Trustees approved the project at its March 26 meeting at a cost not to exceed \$750,000.

The Union's south entryway steps have been deemed unsafe by a structural engineer, requiring the renovation to address the safety concerns and to maintain building accessibility.

In addition, an elevator will be installed to provide students, faculty, staff and visitors access to the Heritage Room on the

second floor to meet American Disabilities Act (ADA) requirements. At this time, the second floor of the University Union is accessible only by stairs or a freight elevator. The projects are expected to begin in June.

The University will use Auxiliary Facility System (AFS) repair and replacement reserve funds to finance the project.

## Nominate outstanding advisers by May 1

Nominations are being accepted for the annual Outstanding Academic Adviser Award. The recipient will receive a \$250 cash award from the Office of the Provost and \$250 in line item expenditures and a plaque from the Center for Innovation in Teaching and Research (CITR). The winner's application packet will be submitted as Western's entry to the National Academic Advisers Association (NACADA) competition. Selection will be made by the Outstanding Academic Adviser Award Committee: the director of the CITR (chair), the previous year's recipient, and representatives from the Faculty Senate, the Council of Academic Advisers, and the Student Government Association. Every college is encouraged to submit a candidate for the award.

**Eligibility:** Full- or part-time faculty members or academic support personnel responsible for the academic advising of undergraduate students and assigned a caseload of academic advisees. The period of service covered by the award is Fall Semester 2009 through Spring Semester 2010. It is expected that nominees will be employed at WIU during the 2010-2011 academic year.

**Criteria:** Nominations will be accepted from students, peers, supervisors, or through self-nomination.

The nominating letter should document excellence in two or more of the following categories:

- Service to students as an adviser
- Student perceptions of adviser's abilities based on evaluations
- Size, composition, and effective management of caseload with emphasis on qualitative management
- Knowledge of advising principles and University rules and regulations and
- Meeting student needs beyond the expectations of the position

**Procedure:** Nominations should be submitted to the CITR, 637 Malpass Library, by **May 1**. Each letter should describe the nominator's perception of the adviser's effectiveness. The nomination must be accompanied by a minimum of two and a maximum of five letters of support secured by the nominator. Letters of support from students are particularly encouraged. If the nominator is not the department chair or supervisor of the nominee, the nominator should ask the chair or supervisor to submit in writing his/her perceptions of the adviser's effectiveness.

## Retirement reception for Schwartz May 7

A retirement reception for **Lorraine Schwartz**, associate professor of art, will be held from **3-5 p.m. Friday, May 7** at the University Art Gallery. Schwartz, who has taught art history from early Christian to 20th century, research in art history and the history of architecture, retires with 29 years of service to Western. She started at Western in 1981, and taught undergraduate and graduate classes throughout her tenure.

Schwartz earned her bachelor's degree at Indiana University (1966) and her master's degree at the University of California at Berkeley (1968), where she was a Woodrow Wilson Fellow. Both degrees were in English literature. She then lived for a year in Italy and changed her field to art history, earning her Ph.D. from Indiana University (1980). Schwartz conducted four years of research in Florence, Rome, and Perugia, participated in an archeological excavation within Troyes Cathedral, and completed the Corso Superiore for Teachers of Italian Literature and Culture at the Università per Stranieri at Perugia. In 1999, she co-directed a summer program in history and art history in Rome. She served on numerous University and departmental committees and received several prestigious named grants—including the Carnegie and Kress foundations—as well as a Illinois Humanities Council grant, a WIU Research Council grant and a Summer Stipend.

## Civil Service Employees Council Elections

- Group V: Secretarial

There are 16 voting members on the council, three from each group, one for the QC campus, and three non-voting members ex-officio: vice president for administrative services, director of human resources, and Employees Advisory Council (EAC) representative. The council

is also involved in several fundraising events, which support the CSEC Dependent Scholarships.

All civil service employees who have completed the six-month probationary period are eligible. Complete the form, include a short statement if desired, and the required supervisor's signature. Those elected will be notified on or before **Friday, April 30**, and will be seated on the council at the May 6 meeting.
