Ms. Carin Stutz

- Thank you to everyone for being here today.
- Due to the hard work of numerous units the income and expenses are more closely aligned. We are moving in the right direction.
- Thank you to the administration and the campus community for all of the hard decisions that you shouldered to move the university closer to a sustainable income and spending alignment.
- More decisions are pending.
- I would like to recognize the APER committee recommendations and the hard work and decisions that went into this process of aligning programs to our strengths.
- The presidential contract listed today has a salary under the salary of the former president of WIU. It ties EIU for the lowest salary paid to a University President. Also note that the give back of salary to the university by Dr. Mindrup while in her Interim role as President was a generous gift.
- The board wishes that it could pay all employees' salaries comparable to other universities.
- The Board thanks the university community for its hard work and dedication to moving Western to a financially sustainable future.

President's Remarks

President Kristi Mindrup

- Good morning to the Board of Trustees, the WIU community, faculty, staff, students, and others who are here with dedication today.
- This has been one of the most intense and challenging years in our professional lives and I know our university community likely agrees.
- Review of the last year's difficulties and changes in Higher Education.
- I see our university emerging from its challenges with promise on the horizon looking to the future.
- This was a period of significant change and a chance to reinvent WIU while also being true to our mission to serve all students, promote social mobility and meet students exactly where they are regardless of their identity and background.

- Over the past three years, WIU has reduced the number of vice president lines in our budget from six to three, freeing up funds to eventually reinvest and strengthen areas that impact institutional growth.
- As Clare Thompson announced her departure as vice president, she shared her ideas for a
 new vision for advancement and alumni relations. The teams within those divisions are
 prepared to rise up and lead in new ways. This will maximize their talents while carrying
 forward the planning as well as the leatherneck spirit Clare promoted. Thank you, Clare,
 for your dedication.
- I want to thank our new interim executive director of development, Amy Crosby, for stepping in to lead that division.
- Other changes included aligning Leatherneck athletics with student success, organizational changes within administration and finance, student success and plans are underway within academic affairs.
- I appreciate the leadership of Provost Mossman and Senate Chair Jeremy Robinett who have been working collaboratively to find program opportunities and guide the development of the refocus in the division.
- I'm appreciative of all of our faculty who step up and take on difficult challenges.
- I would also like to acknowledge the efforts of individuals across our institution and outside of our institution to advocate for our institution's needs within our communities and especially at the state level. UPI, led by Dr. Merrill Cole and John Miller at the state level, have been instrumental in advocating for adequate funding for WIU and especially for bringing the WIU community together with the Anew WIU event.
- Advance Illinois joined the university to promote the equitable funding formula that will benefit higher education and especially institutions like WIU.
- Zach Messersmith and I have been part of the negotiating team that recently concluded our efforts to finalize the bill for equitable funding and we are grateful to Representative Carol Ammons and Senate Majority Leader, Kimberly Lightford, a WIU alum, to move this impactful bill forward.
- Finally, I would like to thank the WIU leadership team, my longtime colleagues, Provost Mark Mossman, Vice President Justin Schuch, Vice President Ketra Roselieb and Director of Government and Public Relations Zach Messersmith for their work to advocate for our institution.
- Thank you to the Board of Trustees for calling on us to make bold moves that you have been asking for over the years. You have found the right team, the right Leatherneck community, at the right time, to make real change and pave the way to a bright future. I am grateful each day for this opportunity to be part of this amazing resilient and dedicated Leatherneck community.
