# A. <u>Approvals from the President</u>

President Huang approved the updated freshman admission policy.

## B. Provost's Report

Provost Abraham indicates that the search for a director for the Office of Distance Education and Support is nearing its end. He anticipates an announcement in the next week or two. Other faculty searches and C.T. Vivian Fellowship are also coming to conclusion with announcements following. Provost Abraham is excited to have new colleagues at WIU.

The Director for the School of Management and Marketing search has concluded; Jonathan Lynne joined us as of April 1 and Provost Abraham is excited to have Jonathan as the school's new director.

The HLC preliminary report was positive. We will get the final preliminary report in about ten days. From there, we will have 30 days to reply to errors of fact. From there we can expect the final report later in the summer after HLC has its official meeting.

Senator Bernards asked Provost Abraham if there was anything in particular that stood out from the premilitary report from the HLC. Provost Abraham said that there wasn't anything that stood out in the conversation with HLC, but we will learn more when we get the preliminary report back.

B. <u>Student Government Association Report</u>
(Elizabeth Orwig, SGA Director of Academic Affairs)

The Printer Technology Fee Legislation has been written. A \$25 flat fee for printing and a three or four cent charge per page after that. President Huang attended the SGA meeting and discussed retention initiatives.

They have moved their SGA meetings to 3-5 on Wednesday in the Capitol Rooms from their historical meeting time of Tuesday evening time of 7-9.

SGA elections are occurring. They end on April 24<sup>th</sup>. Elizabeth Orwig is running for President of SGA. Kinsey Tiemman is running for the BOT position. Jonathon Llewellyn is running with Elizabeth on the same ticket as Vice President. Other nominations will be public at the next Senate meeting.

Senator Filipink asks SGA representative Orwig how many pages of printing the \$25 covers. She believes it's 600 pages, which is the average of most students on campus.

Chairperson Pynes invited all the incoming Senators to participate in the election of officers and indicated who those folks are by placing their names in the Zoom chat. He indicated as outgoing chairperson he would administer the election for the body with the help of Parliamentarian McIlvaine-Newsad using a Google form that allows for anonymous voting. He indicated that self-nominations for officer positions were acceptable and opened the nominations for chair.

# Statement by Senator Thompson:

I am running for Vice Chair because I want to serve the faculty as one of its leaders. I have a record of service through the union as a strong advocate for transparency, the rule of law, for improving faculty and staff welfare through the family leave and end-of-life care benefits. I have routinely served as an advocate for faculty, and even for students, when they are having problems with supervisors or faced with sanctions. I am always on the outlook for improving things. A recent example, providing faculty with lists of their students who made the Deans' List was my idea. Further back, I was instrumental in getting domestic partner benefits for LGBTQ faculty and staff.

I believe the Faculty Senate should act, as a friend of mine at another school once said, as a telescope and microscope: it should detect and address distant problems and opportunities to forestall the former and take advantage of the latter and to minutely study opportunities and problems that are hard to see without patient investigation and discussion—as, for example, the Academic Misconduct Policy, a

procedurally flawed policy written by administrators for administrators. I would also encourage sessions for faculty and staff to familiarize themselves with the fiscal side of the university. For example, it would be useful to have a session that walked faculty through the RAMP document as it contains in one place a good deal of information about the university. The Faculty Senate could also advocate for useful changes in other reporting documents. For example, we could suggest adding median salaries alongside average salaries in the FactBook. Medians provide a different and often more useful way of looking at salary. I would also advocate working with CITR or its new acronym for better support for new faculty and probationary faculty. For example, new faculty need a better introduction to the various retirement options and their shortcomings under Tier 2. I also believe that the Faculty Senate should engage with our elected officials both here in town and in Springfield for the benefit of the university. For example, we could work with the administration to send faculty members to Springfield to discuss bills of interest to faculty and the university or we could make recommendations to the administration regarding bills they are lobbying for or against.

The Faculty Senate has been a more engaged body in recent years. I want to help keep it that way.

## Statement by Senator Brice:

Senator Brice began with the lament that he should have made a campaign video,

Senator Brice indicated that he has served in leadership capacity on the Senate many times. His record of service speaks for itself. He has been a member of ExCo as both vice chair and secretary and has made a long-term approach to Senate governance with regard to policies offered up by the administration so that the university thrives.

Votes were cast using a Google form that was emailed to the 23 incoming Senators in attendance. Senator Thompson won the election 12 votes to 11 votes. Chairperson Pynes thanked both Senators for their willingness to serve the body.

Chairperson Pynes welcomed both Senator Robinette and Thompson to attend the next ExCo meeting on 13 April 2021. He expressed that the work ExCo does is extremely important and he thanked them for their willingness to serve in these leadership roles.

Chairperson Pynes explained that the SNC fills positions for committees and councils for the university. It's the mechanism by which shared governance occurs and faculty have input. If you have questions about being the chair of the SNC, you can ask Senator Robinett. For the last two years he has done an admirable job running this committee for the faculty.

Senator Shupe volunteered to serve on the Vice President of Enrollment Management search committee. No other nominations. Senator Shupe was elected to serve on the VPEM Search Committee.

# III. Reports of Committees and Councils

- A. <u>Council on Admission, Graduation, and Academic Standards (CAGAS)</u>
  (Jason Covert, Vice Chair)
  - 1. Academic Integrity Policy

The issue concerns students selling information from a class in a digital platform. Digital sharing of course material without authorization was added. CAGAS rejected suggested changes having to do with how long the policy would apply and rejected those suggestions.

Chairperson Pynes reminded Senators that because this is a report from one of the Senate Councils, that if there are no objections to the report that it will be accepted. If it is objected to, then it will be removed from the agenda. From there it will need to be placed back on the agenda by the body to continue considering the report.

Senator Robinett asked about item C of the report about posting material online requiring authorization. How is authorization to be given or how would one know if authorization was given? Particularly when we have different professors teaching courses over time. Is this a faculty requirement to grant this authorization.

Senator Robinett clarified that he wanted to know if there was a procedure for granting or withholding consent to share course materials. CAGAS Vice Chair Covert said that there is not a procedure at this point.

Professor Lora Ebert Wallace explained that she thought that policy was describing an inperson situation where a faculty member might give back material that then has to be returned. Mr. Covert agreed with the Wallace assessment.

Senator Brice asks if section C is supposed to punish students who download material from sites like Course Hero. Punish isn't quite what Vice Chair Covert means in this case. He views it as a guide for what students should be doing, i.e., uploading course material.

Senator Brice expresses that Course Hero has a policy that they will take down copyrighted material when faculty ask. But more broadly, he doesn't see how this policy will be effective since students can download the material and it's similar to the material he gives out in class. Vice Chair Covert asks if this is an enforcement question. Senator Brice agrees it is. CAGAS vice chair Covert states that this isn't any different than any of the other enforcement issues that occur with the policy.

If the folks who upload are students who have graduated, there aren't any penalties that we can enforce. And in many cases, Senator Brice says, he can see who is doing the uploading. And there is no way to tell if a student got material from online or from a fraternity file. Vice Chair Covert states that he can see the point.

Senator Dimitrov asks another enforcement question. Who initiates the complaint? Senator Dimitrov doesn't know if the faculty member owns the exam or if it's the property of the student or the university. But he wants to know who initiates the complaint? Faculty? CAGAS? WIU? Vice Chair Covert explains that this is a faculty driven policy and that there are no timeline considerations. It is expected to be while a student is enrolled at WIU.

Senator Banash is sympathetic to the complexity of this issue especially in the time of COVID and all the remote learning. He asks if CAGAS reviewed policies from other institutions that might be more forward looking on this issue so that we might learn something. Vice Chair Covert explained that CAGAS did not look at how other universities are handling this since it was an attempt to handle one minor issue.

Chairperson Pynes reminds the body that they either need to object to this report or to allow it to be approved. It was an attempt to deal with a single request by a faculty member. If the body wants to address the academic integrity policy more broadly, then that would require a different kind of motion and a new charge to CAGAS.

Senator Banash thinks we need to review the policy in consultation with other universities and departments that are strong in pedagogy and maybe intellectual property law. Chairperson Pynes indicates that the dates on the policy indicate it hasn't been updated since 2011, and that he did not hear a formal motion from Senator Banash.

Senator Brice formally objects to the report.

**Motion:** Senator Filipink moves to restore the item to the agenda. Second: (Brice)

Senator Bernards reminds Chairperson Pynes that in 2019-2020 there was an extensive review of the policy when he was CAGAS chair. So this policy was overhauled last academic year. Chairperson Pynes thanked Senator Bernards for reminding him and

indicated that the policy didn't have that update listed. Given the most recent updates, this is a minor change from last year's adoption according to Chairperson Pynes.

Registrar Lynn points out that this policy was approved in February 2020 with major revisions. Soon after that an incident occurred that prompted the current request for a change. This isn't just about sharing physical copies of material.

Senator Dimitrov asks Registrar Lynn to elaborate on what is meant by discovery when it comes to discovering course material. Dr. Lynn indicated that timelines were discussed but the options were kept to grading related options within the course in question. If there are issues that a faculty member wants to pursue after graduation, there are student code of conduct processes in place. But you are correct that there is an implicit timeline to this process. Senator Dimitrov also points out that most of these uploads could be made anonymously. For Course Hero, this isn't an issue.

Senator Taylor also indicates that these issues aren't new and that students engaging in digital sharing needs to be addressed. Part of what we need to be doing as faculty is using the syllabus to link to the conduct policy so that students know they can't share this material. This is about expectations for students as much as it is about enforcement.

Dr. Sheffield explained teacher education is notoriously over accredited. So there is significant effort trying to carve out hours while still meeting state mandates. In this case, we are asking that SPED 390 be increased from 2 to 3 semester hours. That extra hour will take on some of the state mandated content that was offered in SPED 210. This allows for the removal of SPED 210 and reducing the number of hours causing the domino of changes we are seeing here. Dr. Barry Birnbaum is here to answer questions.

Dr. Birnbaum comments that 390 covers the characteristics of disabilities as well as universal design. The new course will focus on new ways to teach students. This is an enhancement for methods for approaching teaching.
