## Western Illinois University Court and Grace Johnston Loan Fund

The Court and Grace Johnston Loan Fund has been made available through the donations of Erwin and Ruth Thompson of Godfrey, Illinois. The fund has been named in honor of Mrs. Thompson's parents. If the loan is granted, you will become part of the tradition of people that have worked to make their dreams come true. Mr. Thompson worked for sixty-eight cents an hour when he came out of the service in 1946. Mrs. Thompson received \$65 a month in 1939 when she began teaching.

The purpose of the loan fund is to provide monies to highly recommended students who are enrolled full time and demonstrate financial need. The loan fund has been designated for students with a WIU Grade Point Average of at least 2.5. This loan is open to freshman through senior class levels.

Your credit history will be reviewed as a part of the application review process. The loan has been set up to allow a student to borrow based on financial eligibility. The loan may be applied for up to four years provided the student maintains full time enrollment at WIU.

This loan **must** be REPAID. The loan will be interest free as long as payments are submitted by the due dates. Failure to submit payment by the due dates will initiate the accrual of interest for the remainder of the loan at an Annual Percentage Rate of 7%. Repayment will begin six months after you cease to be at least a half-time student at Western Illinois University. A minimum monthly payment of \$50 will be due the tenth of each month.

Educational deferment of payments will be allowed. However, verification of attendance at another institution must be submitted and approved prior to the deferment of payments.
